INDIAN FOREST SERVICE EXAMINATION, 2024

Based on the result of the written part of the Indian Forest Service Examination, 2024 held by the UNION PUBLIC SERVICE COMMISSION from 24th November to 01st December, 2024, and the interviews for Personality Test held from 21st April to 2nd May, 2025, following is the list, in order of merit, of candidates who have been recommended for appointment to the posts in Indian Forest Service.

2. A total of 143 candidates have been recommended for appointment under different categories as per the following break-up :-
